REQUEST to RIDE MIDDLE SCHOOL BUS

All students are eligible for transportation services. Please be aware that transportation will be provided from designated pick-up and drop-off points (cluster stops) within our charter region (Auburn, Holden, Leicester, Millbury, Oxford, Shrewsbury, West Boylston, Sutton, and Worcester) and that it **will not** be a door-to-door service. Please fill out one form for each child requesting to ride a bus and return it to the middle school office.

Riding on the bus to and from school is an extension of the school day. The School and the transportation company acknowledge that students riding the bus are under the authority of the school bus driver. Students who do not meet bus riding rules and expectations will be reported to the School. Students who have difficulty behaving on the bus may lose the privilege to ride the bus and transportation will become the responsibility of the parent.

ONLY Students in Grades 4-7 will be allowed to ride on the Middle School Bus.
