Arrival/Dismissal Request Form

2019-2020 School Year

All students are eligible for transportation services. Please be aware that transportation will be provided from designated pick-up and drop-off points (cluster stops) within our charter region (Auburn, Holden, Leicester, Millbury, Oxford, Shrewsbury, Sutton, West Boylston, and Worcester) and that it will not be a door-to-door service.

Riding on the bus to and from school is an extension of the school day. The School and the transportation company acknowledge that students riding the bus are under the authority of the school bus driver. Students who do not meet bus riding rules and expectations will be reported to the School. Students who have difficulty behaving on the bus may lose the privilege to ride the bus and transportation will become the responsibility of the parent.

ONLY students in Grades K-3 will be allowed to ride on the Elementary School Bus. Early dismissals should occur before 2:15pm on full days. Students picked up after 3:30 pm will be charged a \$25 fee. Early dismissals should occur before 11:00am on half days. Students picked up after 12:00 pm will be charged a \$25 fee. Students who are not picked up at the bus stop and are returned to the school will be charged a fee of \$25 per child.
